**The following Rules & Regulations apply:**

- CFM Rule & Regulations apply to performers for set up, conduct and cleanup during market hours. Performers are responsible for respecting spaces provided for performance by keeping them free from unnecessary clutter.
- Performances must be appropriate for all ages.
- The CFM has been careful to choose performers who are appropriate for this venue. We want to put the same care and consideration into choosing performers. We need to vet our applicants to be sure we maintain a quality of performance that is appropriate for the setting and culture of the market. After receiving your application and audio or video samples, we will get back to confirm whether the fit is appropriate and discuss possible dates.
- Donations for performances may be accepted passively in an instrument case or other receptacle provided for that purpose by the performer. The receptacle may include a written sign that informs the public that such donations are sought. No performer shall actively solicit donations by word of mouth, gesture, mechanical devices or second parties.
- Performers are responsible for moderating the volume of their performance to a level appropriate to the surroundings. Performers are responsible for respecting reasonable requests of nearby vendors regarding performance volume and crowd control. The volume may be adjusted at any time by CFM Management.
- Performers shall immediately comply with requests from CFM Management or Staff.
